C. NEW BUSINESS:

1. **VAR 26-008 Babineau Setback Variance:** Daniel and Miriam Babineau are requesting a variance to relax the high-water line setback from 50-ft to 36.5-ft in order to replace the existing nonconforming deck. The footprint of the deck would remain the same. The 0.30-acre site, addressed at 12875 Longhorn Way, is Mcleod & Edwards Wagon Wheel Subdivision No. 2 Lot 25 Block 1 in Section 28, T.16N, R.3E, Boise Meridian, Valley County, Idaho. Action Item.
2. **CUP 26-025 Fluegel Multiple Residences:** Cameron Fluegel is requesting a conditional use permit to allow multiple residences on one parcel. It would include an existing 2400-sq ft dwelling and a proposed 1200-sq ft dwelling located above a garage. The dwellings would share a driveway and a septic system. A new well is proposed. The 2.2-acre site, addressed at 12971 Siscra Road, is located in the NWSW Section 22, T.16N, R.3E, Boise Meridian, Valley County, Idaho. Action Item.
3. **CUP 26-026 Hazzard Bunkhouse Rental:** Kelsey Hazzard is requesting a conditional use permit to short-term rent a bunkhouse. The proposed structure would be an approximately 500-sqft detached A-frame on the rear portion of a lot. The existing 1,156-sqft home is also being short-term rented. The 0.46-acre site, addressed at 156 Boulder Place, is Boulder Creek Meadows Subdivision Lot 81 in the SWSW Section 22, T.16N, R.3E, Boise Meridian, Valley County, Idaho. Action Item.
